HLPOA Monthly Membership Meeting

APRIL 18, 2024

The meeting was called to order by board president Eric Griffin at 8:02pm with 22 members signed in.

The Pledge of Allegiance was recited and roll call taken with all 5 board members in attendance. A motion to accept the March 21, 2024 monthly membership meeting minutes as posted on Next Door and in the April Beacon was made by Chris Hassmann and seconded by Chris Pheiffer with approval from other 2 board members, Eric abstained since he was not present on March 21.

President's Report: Eric Griffin

Eric gave an update on the new Rules and Regulations Committee pertaining to the updates they are doing on our handbook with Rules & Regulations, Bi-Laws and Deed Restrictions. The committee has been going through all these clarifying the wording and basically just making the document more cohesive. A paralegal has the 1st draft in hand and hopes are that the board will have the document and all red line changes soon. We will update as needed and proceed down the proper channels to approve any changes.

Eric also reminded all present of the Annual HLPOA Membership Meeting and election on May 5th. In person voting is at the lodge from 11am - 1:30 pm with the meeting at 2pm. Absentee voting is taking place now, as ballots with explicit instructions were sent out in the April Beacon.

Vic President's Report: Chris Pheiffer

Chris reported on his Maintenance and Facilities Committee and the updates Josh and his crew have been working on, The new trees along both entrance isles (Lake Holiday Lane and Holiday Dr.) have been planted. These trees take the place of the deer damaged Serviceberry bushes planted several years ago. The trees, native to the area are London Plane Sycamores and are the same type trees the city of Willard planted on Myrtle Ave.

The Pioneer Students will be here tomorrow, Friday April 19 doing their community service projects. Josh has landscape and clean up projects lined up around the lodge for the kids to do.

Concrete work around beach and lodge is scheduled within the next month or so. There will be a sidewalk leading from the walk in entrance gate down to the bathroom area, concrete under the lodge for future kayak and beach equipment storage, 4 pads for cornhole, a new pad where the playset stands for shaded gathering area and social activities.....(playset is being moved onto grassy area between stage and volley-ball court) and reconfiguration of a wider lane for golf carts turning onto the path heading south from Lake Holiday Lane.

Kelley G (750) asked if Social Committee Funds were being used to fund the concrete projects. Yes, the Social Committee allotted monies to be used to complete some of this concrete work.

Chris mentioned that a Cincinnati Insurance representative was out today to do a study and to go over all our policy coverage. Most things were fine, there are a couple things in the kitchen that will need to be addressed.

Paul Z (1321) asked if member, Jay Longhurst was still our insurance representative. Yes, we have Cincinnati Insurance through him, but he was not who did the insurance "inspection" today.

Chris stated that the board has hired a new full time maintenance man. Kyle Rush started earlier this month with a probationary period of 90 days. Dom Fratta had asked to cut his hours down to part time.

Treasurer's Report: Henry Jarrett

Henry reported that the revenues (dues, capital assessment, launch fees, summer storage fees, sticker fees etc.) are still coming in, and that we are basically on track with income. Expenses are as expected also. He reiterated that he, Chris and Shana (our accountant) have worked diligently to streamline line items in our budget, and that there is a separate interest-bearing savings account for our capital assessment and roads account earning 4 ½%.

Paul Z (1321) questioned the revenue account line item; marina boat stickers, as the budget is \$30,000.00, which seems high. Chris P answered that question saying he went over all the numbers from last year's registrations 3 times and that that line item is correct.

Secretary's Report: Lynda Snyder

Lynda gave an update on the Social Committee's recent and upcoming events. The "Sun-Sational" Beach Bash for the Eclipse was a great low key community event. The weather was perfect, the Red Beard BBQ Food Truck, Paul Bogner musician, Eclipse glasses, "MOON' pies, "SUN"kist pop and commemorative Eclipse White House Artesian Spring Water and Fireworks immediately after totality ended made the once in a life-time event very memorable.

As previously mentioned, The Pioneer Students will be doing their community service here tomorrow. The Welcome Committee with the help of many generous members will be serving a hot well balanced lunch to the students, their chaperones and our staff. Thanks to all who donated and all who are volunteering to help set up, serve and clean up!

Earth Day is Monday April 22, the social committee would like to encourage you to get out and help the planet (and our community) by cleaning up along the HLPOA roadways, ditches and any green areas you may be near.

The Annual meeting and election is Sunday May 5. The meeting begins at 2 pm and the Welcome Committee will be serving some light snacks as well as offering some things for sale. These sales enable us to provide things for our Welcome Bags which we give to new members on our initial welcoming visit. We are always looking for trinkets and items to place in our bags. (We typically welcome 20-30 new members a year.) Please drop items off at the office or contact Barb Harper (419) 706-0879.

Director's Report: Chris Hassmann

Chris mentioned that the Q & A with Tom Secor representing the Southern 5 Sewer District was very informative. We had 110 members signed in and Tom gave great insight into the efforts he and the committee are putting in to find funding for this major project. The engineering firm has a timeline in place (which can of course be tweaked due to variable), but the estimated completion date of our sewer project is set for December of 2026.

Chris gave an update on the Safety Committee mentioning that safety sheet with lake rules and a lake map have been handed our when you buy your yearly stickers. (He did mention that there was an error on the map that was printed in the April Beacon).

He had scheduled the first meeting with a Huron County Sheriff tonight, but at the last minute he was unable to make it due to a heavy volume of calls. The meeting will be rescheduled. The idea is to get the neighborhood watch program restarted in our community. Talk of what exactly we should be aware of, when to make a call to have a deputy dispatched etc. will be addressed. Talk of updated signage and quarterly or semiannual meetings will also be discussed. Watch for further updates.

Chris also mentioned that the lake committee that several members have asked to form will study issues with raising and lowering the lake, fish population and other lake related topics. Chris stressed the need to be educated on this by using resources available at ODNR and at possibly the roundtable discussions with OLCA members dealing with similar issues. This committee will make recommendations to the board and Josh.

OLD BUSINESS:

Karri W (997) Asked about the possibility of reducing the speed on Rt. 99 (after resurfacing) especially near marina with all hills and valleys making it especially hard to see when turning. Chris H will reach out to ODOT to see what can be done.

Cardinal Drive Cove is still on maintenance list, just other spring things have taken precedence.

Barb H (912) Reminded us that the Welcome Committee is looking for business items/trinkets to place in the Welcome Bags given out to our new members. Drop off at the office or contact Barb Harper (419) 706-0879.

NEW BUSINESS:

Pat K (46) asked if the wet marshy area of the golf cart path on Portage Path (where it was trenched) could be addressed. Seems ii is always a swamp and mosquitos will become an issue. It is on the maintenance list to be looked into.





HLPOA Southern 5 Sewer District Meeting Brief Overview 2024 April 14

Tom Secor our Greenfield Twp representative and Southern 5 Sewer District President gave an overview of the sewer district's progress as it pertains to Holiday Lakes.

There were 110 members signed in to listen to the updates and to ask questions.

Tom gave an overview of how the board of 5 was formed from the surrounding townships plus the city of Willard. He stated that the lawyer John Albers has been good to work with. Tom and fellow board member Alan Babcock meet once a with the hired engineering firm.

First and foremost, the engineering firm of Jones and Henry has been created a timeline (and it is and will be tweaked) when necessary... but as of now the projected END DATE of our project is now set for Monday Dec 21, 2026.

Tom talked about monies available for projects such as ours, and how he and the others are reaching out to all entities involved to try to procure some of these funds for our project. He mentioned needing to find people experienced in grant writing that may be able to help write the grants that are needed to be filed to qualify for some of these funds. Tom also mentioned that we EACH should be reaching out to our senator and district representative to let them know that the sewers are desperately needed at Holiday Lakes and any funding they can help send our way would be very beneficial to us. Tom will send these addresses to Anni who in turn will post on NextDoor, in the Beacon and on the website. Tom will include bullet points to highlight things that we should mention in the letters we send. He would also like to have these legislators out at some point to tour Holiday Lakes so they can see the diversity we have here in our community, both in the homes, and topography of the 1348 potted lots which make up our community. Tom also reiterated that the "exact" cost of this sewer project has not been calculated, and that it is dependent on many things..... (which as we all are aware, CoVid changed EVERYTHING) therefore it is hard to know how much funding help to ask for. Finding funding and exploring funding options is a HUGE part of what Tom is working on. Another group - SCEIG meets every other month to provide funding from various entities. Tom is scheduled to meet with them on June 11, 2024.

Thanks to the engineering firm and the surveying they have done along with some record/fact finding "missions" that they have completed, Tom was able to share some pretty significant numbers. There are 473 "sewage systems" located within the HLPOA, of these 7 are already on holding tanks (as their systems have failed), with that number potentially increasing. 63.7% of the systems here are over 30 years old and 27.9% of the systems are over 50 years old. Please remember, that the expected life of a properly maintained septic system is approximately 30 years. As we all are aware, many tanks are not properly maintained and since we are a recreational lake, with our overflow discharging ultimately to Lake Erie... red flags have been raised with the EPA as we are a part of the Lake Erie Watershed.

Tom brought up the 1st yearly assessment of \$78/lot and a \$10 administration fee. The Southern 5 Sewer District is a municipal entity and has the legal right to assess. This is just the first assessment and was done pretty quickly. The sewer board is looking into things such as non-buildable lots in order to more accurately assess the next year's fees. He mentioned that most members have paid the initial assessment. The ones who have not paid will be turned over to the auditor's office and the assessment and late charges will be tacked onto their property taxes. While on this topic he also mentioned that the initial charges for the main sewage infostructure will eventually be placed on our property taxes for the next 40 years. Overall cost may be decreased by including more homes along the lines, such as the small communities of Stueben and Centerville....

Options like this to decrease the overall cost by dividing it between more homes are still being considered. Tap fees after the construction phase will be passed onto future buyers, so the initial group is not paying the price of someone coming in after the fact. Each home owner will be responsible for the cost of the grinder pump, having electricity to the grinder pump and for decommissioning their old systems. The sewer district may be able to employ 1 company to decommission all the tanks... Things like this are a bit down the road, but are being considered. Some households may not have enough space in their electrical boxes - a 30 amp breaker is required run the needed outlet at the grinder pump...be aware and keep informed with what is happening, so you're not left out when the time comes. *** UPDATE/CORRECTION: The cost to the owner/member for the grinder pump and decommissioning of the old system is currently proposed to be added into the overall cost of the project and as such, eligible to be added onto each member's property taxes. The owner/member will still be responsible for having the necessary electric run to the site of the grinder pump ***

Question was raised about how the monthly usage bills would be calculated. The sewage usage will be determined individually by our individual water meters. The city of Willard will bill the sewer district on a bulk meter reading of effluent that is pumped to them. The city has plenty of capacity to handle our waste.

Question on grinder pumps and expected life. Each homeowner will have their own pump. Pump is a pretty simple machine and basically the seal or gasket. Replacement pumps will supposedly be "in stock" and easily changed out if there is a problem. More details to follow on specifics as the project continues to evolve.

We will have this available to our members & their guests from Memorial Day weekend through Labor Day Weekend. We will also have a food truck Memorial Day & Labor Day.









Meet the staff







HOLIDAY LAKES BOATING SAFETY RULES (plus all Ohio Regulations in OAC 1501)

- *B2. All watercrafts shall keep to the right shoreline or to the right of center buoys where installed. \$250.00 fine
- *B3. All watercrafts must maintain spacing of at least sixty (60) feet between themselves and other watercraft, skiers, surfers, tubers, wake/knee boarders and any other objects on the lake. \$250.00 fine plus any medical or property damage.
- *B4. All watercraft advancing on a skier, surfer, tuber, or wake/knee boarder should not follow less than 90 feet directly behind in the event skier, tuber, or knee boarder falls. \$250 fine plus any medical or property damage.
- *B5. No wake allowed within channels. \$250.00 fine
- *B6. Boaters should not exceed the capacity standards of their watercraft as established by the manufacturer. \$250.00 fine
- *B7. A). All watercrafts must avoid swimming beaches (unless parking in designated beach parking areas) and other designated areas. Watercraft operating within fifty (50) feet of the beaches, swim areas and swim ropes must operate at idle speed. \$250.00 fine
- B). All watercrafts must not exceed the maximum speed of forty (40) miles per hour. If a lesser speed is posted, it must be observed. \$250.00 fine
- *B8. A). All watercraft operating on Holiday Lakes between sundown and sunrise must be equipped with operation lights as required by the Ohio Division of Watercraft. During these hours, watercraft shall operate at idle speed or a speed not greater than five miles per hour. There are red strobe lights located strategically around the lake to serve as a reminder of these idle speed (sunset-sunrise) times. \$250.00 fine
- B). Operation of jet skis (personal watercraft) on the lake between the hours of sunset and sunrise is prohibited. \$250.00 fine
- **B15.** The following equipment must be present and usable in every Holiday Lakes boat to pass inspection for registration (per Ohio Revised Code Chapter 1547 and 1548) \$100.00 fine will be levied for each equipment violation:
- A. Life preservers or ski vests easily accessible for each passenger.
- B. Preservers must be always worn by children less than 10 years old while in the boat. (Applies to all watercraft).
- C. Distress flag (orange two' x 2')
- D. Horn
- E. Fire extinguisher (power craft only) easily accessible and ready for operation.
- F. Bow line (minimum of 15 feet)
- G. Anchor and adequate anchor line (power craft only).
- H. Paddle or equivalent
- I. Coast Guard approved running lights after dark.
- J. First aid kit, bailer (plastic bottle or bucket)
- K. All other equipment as required by ODNR rules and regulations.



- *B16. The following water activities are prohibited (NOTE: Fines for B16 rules will be levied against the parents of any violator who is under the age 16.):
- A. Swimming under the platforms in the beach areas. **\$25.00 fine**
- B. Diving off the dam. \$250.00 fine
- C. Swimming across the main lake. \$100.00 fine
- D. Swimming after sunset. \$100.00 fine
- E. Wading or swimming outside the marked swim areas at the beaches. \$100.00 fine
- F. Water skiing, surfing, tubing, wake or knee boarding after sunset. \$250.00 fine
- G. Trespassing on the spillway. \$250.00 fine
- *B17. Swimming should be confined to within 25 feet of the shore except within marked areas.
- \$100.00 fine
- *B18. Persons must always wear life vests while skiing, surfing, tubing knee and wake boarding or while on jet skis. \$100.00 fine
- *B19. Watercraft towing skiers, surfers, tubers, knee, or wake boarders are required to have an observer in addition to the watercraft operator in accordance with Ohio laws. \$100.00 fine



As we embrace the sunny days and the joy of connecting with friends and neighbors, let's prioritize safety. Please adhere to the speed limits, remain vigilant for pedestrians, and ensure that all golf carts, UTVs, and side-by-sides stay on designated roads and paths. Let's make sure everyone can enjoy our community's outdoor spaces safely.

MOTORIZED VEHICLES:

R22. No motorized Three/Four Wheelers, mopeds, go-carts, trail bikes or other motorized bikes (hereinafter collectively referred to as motorized vehicles) shall be operated within the Holiday Lakes Subdivision, EXCEPT under the following conditions:

R22A. The operator must be a minimum of 16 years of age. The parents of operators who are under the age of sixteen will be fined \$250.00

R22B. The use and operation of such motorized vehicles shall be permitted on the common roadways located in the Holiday Lakes Subdivision and on designated trails/areas authorized by the HLPOA Board of Directors.

Authorized vehicles include: Golf Carts, UTVs, Side-by-Sides, Snowmobiles PROVIDED, that the speed limit and other traffic regulations which apply generally to motor vehicles, are strictly observed. Moreover, the use and operation of such motorized vehicles shall be permitted in such areas as the Board of Directors in their sole discretion, may hereafter designate. Unless and until an area is so designated in writing by the Board of Directors, the use and operation of such motorized vehicles in the Green Areas or other common areas, except as noted above shall not be permitted.

Any person doing damage to said Green Areas or any other property owned by HLPOA will pay the cost of repairs plus a fine of \$250.00.

R22C. All such motorized vehicles shall be equipped with mufflers or other sound reducing devices, and when operated on the roadways of the Holiday Lakes Subdivision, shall be equipped with at least one driving light and at least one combination tail/braking light in good working order.

\$200.00 fine on any such motorized vehicle which is not equipped with mufflers (or other sound reducing devices).

\$200.00 fine on any such motorized vehicle not having at least one driving light and one combination tail/braking light.

R22D. All such motorized vehicles must be annually registered at the Lodge Office of the Association and the owner of any such vehicle must sign a statement that they shall be financially responsible for any and all damage occasioned by or arising from the use of such motorized vehicles.

\$100.00 fine for any such motorized vehicle which is not HLPOA registered.

If any damage is done, the person responsible (or the parent of a minor) will pay the cost of repairs plus a fine of \$50.00.

Operators of such motorized vehicles who trespass on private property or operate such vehicle in violation of this Rule and Regulation R22, shall be subject to having their driving rights of motorized vehicles in the Holiday Lakes Subdivision suspended or revoked, and in addition, shall be subject to possible civil suit and/or prosecution.

Motorized go-carts can only be operated on owner's personal property. Parents /Guardians of go-cart operators will be fined \$250.00 if in violation of the above rule plus must pay for any damage done to either Association on personal properties.







Let's show respect for our neighbors by keeping our furry friends on a leash during walks. And a friendly reminder: please be kind and clean up after your dogs. Your thoughtfulness will be greatly appreciated by everyone in the community

As a reminder, no dogs are allowed on the beach!

PETS:

R21. A. No member, who is an owner of a dog, or other pet, shall permit such pet to run at large, pursuant to Section 955.22 of the Ohio Revised Code, in the Holiday Lakes Subdivision, but shall at all times, keep such pets confined upon the premises of the member or under reasonable control of some person in the form of a leash or tether. Members wishing to report violation should contact either the Dog Warden or Sheriff's Department.

\$100.00 first violation and \$200.00 for each subsequent violation.

R21B. Dogs must not be allowed to bark continuously, or at inconvenient times, to the annoyance of neighbors. Complaints of excessive barking will be investigated and a fine of \$30.00 may be assessed to the property owner for failure to correct the situation. Further violations will be referred to the Huron County Dog Warden for enforcement.

R21C. No resident may have on their property a "vicious dog" meaning a dog that, without provocation, meets any of th following:

Has killed or caused serious injury to any person.

Has caused injury, other than killing or serious injury to any person, or has killed another dog: \$100.00 fine for first violation and \$1,000.00 fine for subsequent violations.

R21D. No resident may have on their property Exotic Animals or Farm Animals

"Exotic animals" includes lions, tigers, leopards, panthers, cougars, bobcats, bears, wolves, foxes, apes, gorillas, alligators, crocodiles, poisonous or constrictor snakes and any other member of the animal kingdom not defined as a domestic animal or farm animal in this section which in not native to the community and presents a risk or harm to human beings.

"Farm animals" include horses, ponies, mules, donkeys, cows, pigs, sheep, goats, buffalo, llamas, alpacas, and any other animals which are raised for the purpose of providing food, entertainment and clothing or to be used as a beast of burden and not classified as a domestic or exotic animal in this section.

IMPORTANT PERMIT UPDATES

EFFECTIVE IMMEDIATELY

GREENFIELD TOWNSHIP MEMBERS (ONLY) MUST HAVE A PERMIT FROM GREENFIELD TOWNSHIP FOR THE FOLLOWING:

- A NEW BUILD

All work must comply with dimensions and set backs of Holiday Lakes Building and R.C.O. Codes. If more than one line item is to be performed at the same time, each permit fee applies. The only exception is a New Home Permit, which includes septic, culvert, and drive. No combining multiple jobs into one permit. If work is started without applying for and receiving permit with approved plans, the permit fee will be doubled, plus \$500 fine.
