

#### 2025 April 17 HLPOA Monthly Membership Meeting Minutes

The meeting was called to order at 7:02 pm by HLPOA Board Vice President, Chris Pheiffer and the Pledge of Allegiance was recited.

Secretary Lynda Snyder took roll call president Eric Griffin was and excused absence and Chris Hassmann was enroute to the meeting coming home from a work conference in Washington DC.

The minutes from the March 20 membership meting were approved as posted on NextDoor and printed in the April Beacon.

President's Report: via Chris Pheiffer

Chris gave an update from Eric's most recent discussions with Scott from the Brass. Repairs are necessary to the floor under the ice machine in the restaurant. The water damage involves the subfloor under the laminate. Talk of replacing the flooring under the ice machine with tile after the subfloor damage is repaired is ongoing.

Jeff H 912 asked about a drip tray under the ice machine to prevent damage in the future.

Vice President's Report: Chris Pheiffer

Chris gave an update on the maintenance crews tasks that have recently been completed. A new trail groomer was recently purchased. This will work wonders on all our trails, evening out ruts and leveling the trail stone after washouts.

The recently relocated Brass deck steps that were found to be varying heights have been redone and are now all the same height except for the very top step which is off by just an inch or so.

Pioneer Students will be here Friday April 20 to complete their community service commitment. We were recently contacted to see if Josh had work for an additional 30 students that day. He is planning to have these students landscape around the new Brass Decking.

We will be pouring a cement walkway to tie into the existing cement at the base of the new Brass steps that will then run through the grass and go all the way to the Brass' docks

Josh and crew recently did some tree work to the association owned lot near the lodge beach, and to the area near the newest marina building.

Per our 3-year road rotational tar and chip schedule, we have approved the Greenfield, Ramona, Meadowview and Lakewood areas for their scheduled tar and chip this year. We are also addressing some problem areas with pavement.....mainly the causeway and Abby Lane.

Thank you to the mowing volunteers Joe Vondrasek and Jeff Harper who have been mowing until our summer help can start. We appreciate you!

Chris then introduced Renee Thompson our new office manager. Renee has been with us almost a month and has already obtained her notary endorsement.

Chris also shared the information that board candidate Kevin Vargas has withdrawn his candidacy bid after realizing that the position was not an open seat due to a term limit, but rather 1 in which a current board member is seeking re-election.

Chris then gave a brief S5SD update. The good news is that the tax base for this project has a 45-year term. Tom also felt that 0% financing of this project is a pretty sure thing, and the sewer board is also apparently very close to pinning down a 4,000,000 principal forgiveness loan.

The S5SD hopes to have the entire project cost and a financing plan set by the fall or 2025, as well as what the monthly fees will be from Willard for handling our waste. The S5SD recently held a meeting with residents on Niver and Egypt Roads to "invite" them to join the project.... the more owners that join, the more the cost is divided up. So far 13 of those residents HAVE committed to the project with more expected to join in when the costs are closer to being determined.

The S5SD is planning on holding an informational meeting for our residents and the project engineers to talk out the details and answer more of our questions. Tentative time frame for this meeting is May 2025.

Tom also is looking into special financing for qualifying individuals to help with the homeowner's upfront cost of connecting their home to the grinder pump. (The project will cover from the road to the grinder pump, but it is the homeowner's responsibility to cover the cost from the house to the grinder pump.)

The yearly per lot assessment the S5SD has collected the past 2 years is likely to continue until the project is complete and the tax basis is established. The S5SD promises better communication on the yearly cost of this assessment.

Cheryl D 1122 Asked if we will be given a list of companies that will do the electric and sewer hookup from our homes to the grinder pump. We would hope that to be the case, but that would also be a question to ask the engineers at the proposed upcoming May informational meeting.

Brad N 1280 Asked where the \$4,000,000 forgiveness loan is coming from. Once again, a question for the upcoming informational meeting.

Jane N 1280 Wondered if the locations we signed off on last fall could be tweaked at all? We think so, there should be a finalization process. She then mentioned that she wanted Josh to know that the Greenfield culvert clean out that he did last fall was not draining properly.

Kevin V 916 Agreed that most would pay a bit more if the entire project would utilize 1 vendor to do all the hook-up work, similar to what the district is panning to do for the decommissioning of

all the old systems. We think the S5SD is considering this.

Jeff H 912 and Rose Ann 943 also agreed with Kevin's statement.

Treasurer's Report: Henry Jarrett

Henry reported had the Revenue/Expense Report thru 3/31/2025 available as a hand out. He stated that at the end of March about ½ of our yearly budgeted revenue has come in and that about 1/5 of the yearly budgeted expenses have gone out. All in all, we are in good financial shape right now.

Brad N 1280 Asked about the issue on the ballot about funding our reserve account. There is confusion on the issue. This is an item that needs to be voted on annually....and there is always a bit of confusion. The Ohio Revised code was changed a few years ago, requiring us to fully fund our reserve account. Per our deed restrictions 7% of our annual dues are set aside for capital improvements. 3 years ago, we passed a 5-yr assessment of \$200/yr. to go directly into an account to fund our capital reserve fund. There is no way we can fully fund our reserve fund (this would require a huge sum as we would need to be able to have in our reserves funds to cover every capital asset HLPOA owns.) Therefore; we hope the vote favors to waive fully funding our reserve account. We do still fund the reserve account; we are just not FULLY funding.

Jane N 1230 Asked that before any of the Reserve Fund is spent, will the membership be advised. We, the HLPOA board feel we are very open and transparent on how lake funds are and will be spent.

Kevin V 916 Asked about the amount received from the brass in March from the .50 Lake Fee. The monthly Brass rent is \$2750/month. The line total for the Brass for March was \$3036, so the .50 per closed ticket charge netted \$286.00 for March. We have \$10,000 revenue budgeted for this Lake charge in the 2025 budget.

Karen D 760 Asked about a discrepancy in the budget with the Social Committee funds. Henry will meet with Karen and figure out the issue.

Kevin V 916 Asked about the "give back" due Lisa Stumpf when she donated \$2000 of "left over" fireworks fund collected. A private individual was putting on his own show that year, so it was decided to donate these collected funds to the Social Committee. The Social Committee voted to give the funds back to Lisa. Kevin asked if the Social Committee was able to donate more funds to help cover the cost of the liability insurance for the fireworks. When the ORC changed a couple years ago allowing individuals to set off fireworks legally on certain days, this DID NOT imply that an HOA OR POA organization was included under this code. They are still required to hire a licensed professional to set off fireworks. Due to the ORC and the liability, the lake cannot sponsor or support funding of fireworks UNLESS we hire a licensed professional.

Karen D 760 Asked about hosting fundraisers and putting donation information in the Brass or on the community bulletin board. There is nothing holding an individual from hosting a fundraiser to raise money for said fireworks. Purse Bingo, selling game squares etc. were discussed. This can be done in the future, but the immediate cause is for this year's funding. The liability insurance alone is over \$4,000 and to put on the type of show the community is accustomed to, an additional \$8,000.00 needs to be collected. The talk of a 20-minute show, seemed to go over well.... not too long or too short. The issue is that it's early in the "season" and donations are slow to come in. The "crew" would like to purchase certain fireworks now rather than later ...as the price may be lower now, and certain types are only available at certain times of the year. Talk of a "thermometer" displaying the amount collected vs amount needed.... was held also.

Kevin V 916 Asked about the Pioneer Student Volunteer Day. The Welcome Committee typically prepares a hot lunch for the students, volunteers and our lake staff. We were informed of an additional 30 kids being sent to the lake. Donations have been collected via the Next Door App to help cover the costs incurred for hosting this event. Our community has responded to our need. Kelley G 750 Mentioned she was 1 of about 20 that took the Boater's Safety Course last Saturday. This course is required for anyone operating anything over a 10hp vessel, if you were born after 1982. Kelley reported that the course was more geared to larger bodies of water and stated some of the rules that are different in our boating regulations. It was suggested that a class designed with our lake rules possibly be offered especially for new residents, so they understand the rules we go by. This has always been a hot topic. It is a great idea, but getting people to come is the issue.

Secretary's Report: Lynda Snyder

Lynda gave a brief update on Social Committee Calendar of events:

Our recent Easter Bunny Bonanza was a huge success. We had 40-45 kids attend with their parents or grandparents. Miller's Easter decorated donuts with milk or coffee were served, the kids made a bunny craft, visited with the Easter Bunny, and participated in a prize raffle with every child going home with some kind of prize. It was topped off by the Easter Bunny himself leading the way down to the 800 eggs "hidden" on the grass near the beach.

The annual upcoming Pioneer Students workday is on Friday 4/25. The Welcome Committee is once again preparing and serving a hot lunch for the students, chaperones and our staff. We are accepting donations of items for this function, please see Lynda's NextDoor post regarding this event

Earth Day Clean will take place with us filling up the dumpster on 4/27, Clean up around green areas, roadways and ditches. We will have supervised collection of litter picked up to be placed in the HLPOA dumpster for 1 hour on Sunday 4/27 from 3-4 pm. Please watch NextDoor for more details

The Election and annual meeting are Sunday 5/4. Voting takes place at the lodge from 11:00-1;30, or follow the directions to cast your absentee ballot. The Welcome Committee will be providing cookies and water, selling Directories, car decals and the official HLPOA apparel that the office has available

Our community garage sale is set to coincide with Willard's Garage Sales. Saturday 5/10. Please see Renee in the office to pay your \$5.00 to be included in our Willard Times Junction ad and to have a brief description, as well your address and ad times on our HL sale map. Your fee and "ad info" is due to Renee in the office by Friday 5/2

Lynda attended the OLCA (Ohio Lake Community Association) spring conference in Dublin last Wednesday and Thursday. There are 23 member lakes in Ohio with most being incorporated around the same time Holiday Lakes was. The issues we face with rules, regulations, bylaws and deed restrictions seem to be a common issue as well as dredging, lake management, wake boat damage, dues and assessment collection etc. There were several breakout sessions specifically dealing with such topics. This conference and the acquaintances are a great source for information, networking etc. The OLCA fall conference will be held Sept 17, 18 at Rome Rock Lake Ashtabula County. Please see Lynda for more info.

#### A reminder all about the burn ban as stated by Huron County:

Please be advised that a burn ban is currently in effect in unincorporated areas of Huron County, Ohio, due to the statewide ban on open burning during the spring and fall. The ban specifically prohibits open burning outdoors from 6:00 AM to 6:00 PM during the months of March, April, May, October, and November.

Next Lake Fest and Social Committee meetings are Wednesday 5/14 at 6pm and 7pm respectfully. Directors Report: Chris Hassmann

Chris reported that several members of the Safety Committee and the community met with 3 Sherrif Deputies after the March 20 membership meeting. Discussions were held on Neighborhood Watch activity and how to promote safety and our rules and regulations on the water and on our cart paths and green spaces. We had hoped to have an on water and cart path patrol with deputies during some of the busiest weekends, however it looks like we would have to hire a private security company for the on-water patrol. Discussion is still ongoing.

The Lake Committee has had some behind the scene leg work being done in hopes of developing a 8-10 yr and beyond plan for best managing our lakes, including future dredging and lake lowering plans. The goal is to formulate a plan, then carry out the plan in years to come. The first step to formulate said plan is to know our lake, thus having a bathometric study done that will give us current lake depths and silt levels. Chris has 1 estimate from an engineering company that does this work for \$14,300.00. He has other companies to contact to try to obtain other bids.

Melissa H 1315 Said she and Chris (also Henry and Chris) have been digging through the (messy) lake archives (in storage areas under the lodge and in the lodge) to try to find the original drawings of when our lakes were first dug. If anyone in the community has information or original historic drawings, please let Chris H. know.

Jeff H 912 Asked if it really matters what the bathometric survey costs, we need it done because we "need" the lake.

Cheryl D 1122 Asked about dredging, saying it has been talked about since they bought on the east side of 99 several years ago. That side of the lake is extremely shallow and many can't even put boats in at their lake front homes. She wants to ensure that the dredging stays as a main focus and top priority. Chris H responded that that is why a lake management plan needs to be implemented. It can be followed as board members rotate in and out of "office". But also be advised that any dredging plan will come at a cost. Their will be ramifications to all. Steps will need to be taken to make sure most of the "bleeding has stopped" to slow the shore erosion into the lake and to also deter what comes in with the run off into the lake. Ohio EPA will be involved as there are specifics when it comes to the materials dredged out of the lake. Please be advised also that we property owners are facing a lot of upcoming expenses already with the sewer project and probable spillway work needed done. Dredging is a dire need, but a well-executed lake management plan needs to come first to direct and "control" the project to assure it is done to the best of our ability.

Kevin V 916 Agreed that reaching out to former property owners who may have knowledge of original lake depths etc can be a great resource. He is quite sure he has seen original HLPOA maps in member's homes.

Brad N 1280 Asked if the older documents cand be digitalized, and Chris H said some of the large "blue print" sized charts he has come across he already has planned to take to have digitalized.

Lake Management Plan as we have been discussing.

#### **NEW BUSINESS:**

Rose Ann V 943 Member Jim Stricker has volunteered to upgrade the lodge wifi to hopefully reach out onto the beach. He will call the office to schedule a time for Josh to "show" him around and get information on types of mesh systems or routers that can be used.

Jeff H 912 Reported that now that he has been helping to mow and been in the maintenance building and has seen firsthand how well maintained and immaculate Josh and Kyle keep all of our machinery, tools and equipment.

#### **Holiday Lakes Safety Committee Reminder**


All boaters at Holiday Lakes must follow our published association rules, which work alongside Ohio state boating laws. Since these rules are directly safety-related, there is a \$250 fine for the first offense plus liability for any damages. These rules aren't meant to penalize our community members—they exist to protect everyone's safety and enjoyment of our beautiful lake.

Additional Important Reminder - Nighttime Boating Lighting: We've noticed some confusion about proper boat lighting after dark. When operating your boat at night:

• You must use navigation lights (red and green at bow, white at stern) whenever your boat is moving Docking lights are for docking only—using them while cruising can blind other boaters and interfere with everyone's evening enjoyment

Your cooperation helps maintain the safety and beauty of our lake community. Thank you for doing your part to keep Holiday Lakes safe for all.

- B2. All watercrafts including boats, personal watercraft, non-powered boats etc. shall keep to the right shoreline and must travel in a counterclockwise pattern around the lake unless returning directly to a downed skier, tuber, wake surfer or kneeboarder.
- B3 All watercrafts must maintain a distance of at least 60 feet between themselves and other watercraft, skiers, wake surfers, tubers, knee boarders and any other objects on the lake.
- B4. All watercraft advancing on a skier, wake surfer, tuber, or knee boarder should not follow less than 90 feet directly behind in the event skier, wake surfer, tuber, or knee boarder falls. Watercraft engaged in towing a skier, wake surfer, tuber, knee boarder has the right of way.
- B5. No wake is permitted within channels or designated area and all watercraft shall operate at idle speed. Idle speed means the slowest possible speed needed to maintain steerage or maneuverability.
- B6. Boaters should not exceed the capacity standards of their watercraft as established by the manufacturer.
- B7. A). All watercrafts must avoid swimming beaches (unless parking in designated beach parking areas) and other designated areas. Watercraft operating within 50 feet of the beaches, swim areas and swim ropes must operate at idle speed.
  - B). All watercrafts must not exceed the maximum speed of 40 miles per hour. If a lesser speed is posted, it must be observed.
- B8. A). All watercraft operating on Holiday Lakes between sunset and sunrise must be equipped with operation lights as required by the Ohio Division of Watercraft. During the hours between sunrise and sunset, watercraft shall operate at idle speed. Idle speed means the slowest possible speed needed to maintain steerage or maneuverability.
  - B). Operation of jet skis (personal watercraft) on the lake between the hours of sunset and sunrise is prohibited.
